Short Title</b> This regulation may be cited as “Regulation to Re-amend the Regulation issued for Re-determination of Land Provided by Lease and Administered in Rent in Oromia Region No.128/2010, No. 132/2011”.</p> <p><b>2. Amendment</b> A new article “h” is added on regulation to re-determine land provided by lease and administered in rent in Oromia region No.128/2010 next to the provision under sub-article 12 “g” as follows.</p>
