**PROCLAMATION NO. 138/2008**  
**A Proclamation to Amend the Oromia**  
**National Regional State Proclamation to**  
**Provide for the Re- Establishment of**  
**Investment Administration No. 115/ 2006**

**WHEREAS,** it is necessary to reestablish and determining the powers and duties of the Investment administration organs and enabling them to create conducive environment important for the expansion and enhancement of investment activities that meets the implementation of business Process reengineering in the region;

**WHEREAS,** it becomes decisive to efficiently establishing investment administration and making it capable to work by itself and to mitigate the problems prevailing in the process of investment;

**WHEREAS,** decentralizing the prevailing work load only at the top hierarchy and sharing decision making powers to the lower levels of investment administration organs down at various levels is found decisive to speed up the work process;

NOW, THEREFORE, in accordance with Article 49(3)(a) of the Revised Constitution of the Oromia Regional State, it is hereby proclaimed as follows.

**PART ONE**

**General Provisions**

**1. Short Title**

This Proclamation may be cited as "Proclamation No.138/2008 Issued to Amend the Oromia National Regional State Proclamation to Provide For the Re-Establishment of Investment Administration No. 115/2006."

**2. Definitions**

Unless the context requires otherwise, in this Proclamation:

- 1) "Administrative Council" means The Administrative Council of the Oromia National Regional State.
- 2) "Board" means The Investment Board of the Oromia Region.
- 3) "Commission" means The Oromia Investment Commission and its branch offices. Hierarchically.
- 4) "Rural land" means land outside of the urban area or not delineated under urban master plan or not decided by the appropriate organ to be delineated under urban master plan.
- 5) "Urban land" means land held under urban master plan or decided by legally authorized organ to be delineated under urban land.
- 6) "Mineral Land" means Rural and urban land which is convenient for mineral investment and decided for the same by the concerned organ.
- 7) "Tourism site" means Rural and urban land which is convenient for tourism operation and allocated for the same by the concerned organ.
- 8) "Domestic Investor" means an investor who is Ethiopian by birth or nationality.
- 9) "Foreign Investor" means an investor who is foreign both by birth and nationality.
- 10) "Ethiopian investor by birth" means an investor who is Ethiopian by birth but foreign by nationality.

- 11) “Invastimentii babal’isaa ykn fooyya’iinsaa,” jechuun dandeettii oomishaa, ykn tajaajila kennuu dhaabbatichaa dhibbeentaa digdamii shanii (%25) oliin humna namaafi kaappitaala guddisuu jechuudha.
- 12) “Kaappitaala,” jechuun maallaqa biyya keessaa ykn biyya alaa, sanadoota daddabraa, meeshaalee oomishaa, ykn kenna tajaajilaa ittiin kennan, gamoo, baajata hojii adeemsiftuu ka’umsaa, akkasumas mirga qabiyyee jechuudha.
- 13) “Naannoo,” jechuun Naannoo Oromiyaati.
- 14) “Nama,” jechuun nama uumamaa ykn qaama mirgi namummaa seeraan kenneef jechuudha.

13) “Region” means the Oromia Region.

14) “Person” means natural person or an organization that acquired legal personality.

**3. Establishment**

The Oromia Investment Administration (hereinafter referred to as “Investment Administration of Oromia”) is hereby re-established.

**PART TWO**

**Organs of Investment Administration**

**4. Organization**

The Investment Administration of the Region shall have the following organs:

- 1) Investment Board,
- 2) Investment Commission,
- 3) Zonal Investment Committee,
- 4) Investment Committee of the towns,
- 5) Worada Investment Committee

**5. The Investment Board**

1) The president of the Regional State Government shall be the chairperson of the investment Board.

2) The Board shall be accountable to The Administrative Council of the Regional State

3) Procedural issues, number of board members and their appointment shall be determined by the regulation to be enacted by the Administrative Council.

**6. Powers and Duties of the Board the Board shall have the following powers & duties**

- 1) It shall evaluate policy and strategies designed with respect to investment; submit it to the council of the administrative council of Regional Government and implement upon its approval.

- 3) Investimentii ilaalchisee qajeelfama adda addaa ni baasa;

- 5) Dhimma investimantii irratti Komishinichaafi qaamolee sochii investimentii keessatti gahee qabaniin murtaa'an ilaalchisee ol'iyyannoo dhiyaaterratti murtii ni kenna. Murtiin Boordichi dhimma investimentiirratti kennus murtii dhumaa ta'a;
- 6) Lafa investimentii baadiyyaafi magaalaa qaama dhimmi ilaaluun akka qophaa'u ni taasisa; raawwiisaas ni hordofa;
- 7) Pirojektoota gurguddaa faayidaa ol'aanaa qaban ilaalchisee investaroota hayyama investimentii qabaniif lafa ni kenna; ni bulcha. Tarreeffamni isaa dambii Manni Maree Bulchiinsa Mootummaa Naannichaa baasuun kan murtaa'u ta'a;
- 8) Beenyaan lafa investimentii akkaataa seeraatiin akka kaffalamu ni taasisa; haala raawwiisaa ilaalchisee qajeelfama ni baasa;
- 9) Lafa investimentii qophaa'eeff bu'uurri misoomaa dursee akka galu ni taasisa;
- 10) Ijaarsa seeraan alaa lafa investimentii irratti gaggeeffamu ni too'ata; tarkaanfii sirreeffamaas ni fudhata.
- 11) Wal harkaa fuudhiinsa dhaabbilee Mootummaa dhimma investimentiitiif akka oolan murtaa'an ilaalchisee haala raawwiisaa ni hordofa;

**7. Koree Investimentii Godinaa**

- 1) Walitti qabaan Koree Investimentii Godinaa Bulchaa Godinaa ta'a.
- 2) Itti waamamni Koree Investimentii Godinaa Boordiidhaaf ta'a.
- 3) Hojimaanni, baay'inniifi haalli muudama miseensoota koree investimantii Godinaa dambii Manni Maree Bulchiinsa Mootummaa Naannichaa baasuun kan murtaa'uu ta'a.

- ፯) ከፍተኛ ጠቀሜታ ላላቸውና ትልልቅ ኘርዘኞች ኢንቨስተርቹ የኢንቨስትመንት ፍቃድ ካላቸው መሬት ይሰጣል፤ ያስተዳድራል። ዝርዝሩ የክልሉ መንግስት አስተዳደር ምክር ቤት በሚያወጣው ደንብ መሠረት የሚወሰን ይሆናል።
- ፰) የኢንቨስትመንት መሬት ካሳ በሕጉ መሠረት እንዲከፈል ያደርጋል፤ አፈጻጸሙን በሚመለከት መመሪያ ያወጣል።

**14. Powers and Duties of the Investment Committees of the Towns Accountable to Zone Administration**

The Investment Committee of the towns accountable to zone shall have the following powers and duties:

- 1) It shall authoritatively lead and supervise the investment activities in the town.
- 2) Based on the Board Directives, it shall give decisions for investors having license and submit investment projects to the Committee.
- 3) It shall conduct follow-up on the continuous preparation of investment land, cause to be prepared in time before the land in the stock running out and be sure its being readily available.
- 4) It shall follow-up and ensure whether the concerned organ to handle and transfer relevant information for investment promotion to the Town Investment Office and cause to be transferred.
- 5) Facilitate appropriate conditions for the rehabilitation of the persons evicted due to investment activities.
- 6) Follow-up whether the estimation of compensation is legal based and gives correction if there is any shortcoming.
- 7) Supervises an illegal construction on investment land and takes corrective measures.
- 8) Cause the land allocated for investment, without the decision of the Board, not to be used for other services.
- 9) Cause the in advance fulfillment of the infrastructure in the land prepared for investment activities.
- 10) Undertake other activities given to it by the Board and Zone Investment Committee.

**PARTTHREE  
Miscellaneous Provisions**

**15. Obligations of Concerned**

- 1) The Organs with the duty to prepare investment land shall have the obligation to prepare investment lands continuously before the exhaustion of the prepared land.
- 2) Compensation estimating organs, having the obligation to estimate only on the legal basis shall be accountable for the improper estimation of compensation individually as well as in common.

- 3) Any concerned organ, based on the direction of the law, has to implement the structure given from the investment.
- 4) Any Organ providing services to investors has to deliver the service without any complication.
- 5) Any concerned organ shall transfer evidences and in formations of investment promotion to the structures of investment.
- 6) Any organ is obliged to give support for the implementation of this Proclamation.

**16. Inapplicable laws**

- 1) The Oromia Investment Administration Proclamation No. 115/2006 is hereby repealed.
- 2) Any law, regulations, directives or practices which are inconsistent with this Proclamation shall not apply with respect to matters provided for in this Proclamation.

**17. Transitory Provisions**

- 1) Activities started in accordance with the previous laws and directives shall continue in accordance with the provisions of this Proclamation.
- 2) The existing laws and directions and directives are issued for the implementation of this Proclamation.

**18. Power to issue Regulations and Directives**

- 1) The Regional Council of State shall have a power to issue regulations for the proper implementation of this Proclamation.
- 2) The Investment Board may issue directives to implement the Proclamation and regulations issued in accordance with this Proclamation.

**19. Effective Date**

This Proclamation shall come into force as of Jan 1<sup>st</sup>, 2008.
