been proclaimed in accordance
with the Revised constitution of
Oromiya National Regional state
Article 49(3) (a)

1. Short Title

This proclamation may be cited as

- 1) The provision of article 1 is amended as fallows
"Oromia Radio and Television organization establishment proclamation"
 - 2) The Provision of article 2 (4) amended as follows
"Organization means the Oromia Radio and Television organization established by this proclamation"
 - 3) The provision of article 2(5) amended as follows Board means a higher organ established by this proclamation that administers Radio and Television organization of the region .
 - 4) The Provision of article 2(6) repealed
 - 5) The provision of article 3 is amended as follows the Oromia Region Radio and Television organization hereafter called organization has been established by this proclamation as an independent legal entity.
 - 6) The provision of article 7 (1) (C) here by amended as follows Deputy General managers
 - 7) The provision of article 7(2) is amends as follows the organization shall have different structures to perform its duties
 - 8) The provision of article 8(1) here by amended as follows the organization shall disseminate valuable news and information through radio , Television and Website in afan Oromo and different language to the people of the region
 - 9) The provision of article 8(3) here by amended as follows creates different conducive forum to enable the people to exchange views, discuss and give opinion to reach a national consensus
 - 10) The provision of article 8(8) here by amended as follows provide photograph, documentation of moving pictures and advertisement services.
 - 11) The provision of article 8(9) here by amended as follows.

14) The provision of article 11(1) here by amended as follows assure that the organization applies policies, laws, regulations and directives or radio, Television and website.

15) The provision of article 11(2) here by amended as follows monitors policies and laws issued by the govt's that should be understand by the public are dispatched by radio, television and website of the organization timely.

16) The provision of article 11(6) here by amended as follows evaluate the general content of news, programs and other reports transmitted through radio, television and website of the region provides directive on how to improve their performance.
