Proclamation No. 170/2012

A Proclamation Enacted to Revise the Powers and Duties of Oromia National Regional State Executive Organs Amendment Proclamation No. 163/2011

WHEREAS, it is necessary to reorganize the powers and duties of rural and urban land administration system and development stated in A Proclamation Enacted to Revise the Powers and Duties of Oromia National Regional State Executive Organs No. 163/2011;

WHEREAS, it has become necessary to undertake appropriate management and development of urban land and immovable property in the modern information system to ensure transparency and reliable urban land management system;

WHEREAS, it is necessary to amend the powers and duties of some executive organs;

NOW, THEREFORE, in accordance with Article 49(3) (a) of the Revised Constitution of the Region No.46/2001 it is hereby proclaimed as follows.

1. Mata Duree Gabaabaa

1. Short Title

This Proclamation may be cited as “Proclamation No. 170/2012 A Proclamation Enacted to Revise the Powers and Duties of Oromia National Regional State Executive Organs Amendment Proclamation No. 163/2011.”

2. Amendment

1) Definition:

Under definition of Proclamation No. 163/2011 Article 2 Sub Article 17, new Sub Article 2 (18) is added as follows;

18) “**Cadastre or Legal Cadastral Map**” means the data that indicates major land use map and all features found on the land with its attributes’ in all direction which can be used as a basis for estimation of land and property value.

2) Proclamation No. 163/2011 is amended as follows.

Article 12(13) Land and Environmental Bureau is amended as follows.

13) Rural Land and Environmental Protection Bureau.

3) Article 27 the powers and duties of Land and Environmental Bureau is amended as follows.

Rural Land and Environmental Protection Bureau shall have the following powers and duties:

1) Prepare and submit rural land and environmental protection laws, policy and strategy to the concerned body; implement the same upon approval, follow up and control its implementation;

2) Administer rural land of the region, develop modern rural land data system and prepare rural land cadastral (legal) map;

3) Prepare rural land use plan and implement the same upon approval; cause to be implemented; follow up, control; give the necessary support;

4) Identify and cluster rural land based up on its use, plan and provide the same to different organs for development work as may be necessary; control the same;

5) Register rural land possession in accordance with law, measure it, issue land holding certificate to the rightful body, register and approve agreements regarding rural land use right lease, develop commonly, donation and succession right transfer;

- 9) Lafa baadiyyaa fi eegumsa naannoo ilaalchisee wal diddaa uumame qaama dhimmi ilaallatu waliin ta'uun furmaata akka argatu ni taasisa;
- 10) Qaamota qabeenya uumamaa seeraan ala itti fayyadamuun dhiibbaa geessisan deebiisanii akka misoomsan ni taasisa, tarkaanfii seeraa ni fudhata, akka fudhatamus ni taasisa;
- 11) Lafa baadiyya hojii misoomaa fi tajaajila adda addaatiif ooluu danda'u u qoratee ni qopheessa;
- 12) Lafa baadiyyaa gara magaalaatti daangeeffamu ilaalchisee ragaa barbaachisaa ta'ee qopheessuun qaama dhimmi ilaallatu waliin walharkaa fudhiinsa ni raawwata;
- 13) Haala qabatamaa naannichaa irratti hundaa'uudhaan madaallii sadarkaa eegumsa naannoo ni qopheessa, yammuu mirkanaa'u hojii irra akka oolu ni taasisa, hojii irra oolmaa isaa ni to'ata;
- 14) Hojiiwwan misoomaa adda addaa gaggeeffaman kamiyyuu naannoo irratti dhiibbaa akka hin qaqqabsiifne ni to'ata;
- 15) Sagantaaleen pirojektoota misoomaa mootummaadhaan, miti-mootummaa fi qaamota biroon yammuu karoorfaman sakatta'iinsi dhiibbaa naannoo dursee akka adeemsifamu ni taasisa, ulaagaalee sakatta'a dhiibbaa naannoof barbaachisu ni qopheessa, qaama barbaaduuf ni kenna, hojii irra oolmaa isaa ni to'ata;
- 16) Hafteewwan oomisha warshaalee fi hazbaan magaalota keessaa bahan sirna madaallii ikoolojii akka hin xureessine ni to'ata, tarkaanfii sirreeffamaa ni fudhata, akka fudhatamu ni taasisa;
- 17) Ragaalee fi odeeffannoo lafa baadiyyaa fi eegumsa naannoo ni gurmeessa, ni kuusa, ni bulcha, qaama dhimmi ilaaluuf ni beeksisa;

- 7) Control illegal rural land occupation and construction; take legal action, cause legal action to be taken, work with the concerned body;
- 8) Undertake estimation of compensation for the expropriated rural land for the purpose of development with the concerned body, pay the compensation before displacing the people from their possession; rehabilitate those displaced with the concerned body; support, follow up and control;
- 9) Solve disagreements regarding rural land and environmental protection with concerned body;
- 10) Enforce legal measures for misuse of natural resource and promote natural resource conservation and rehabilitation;
- 11) Prepare rural land that could be used for development and other services based on research;
- 12) Prepare the necessary data concerning rural land demarcated under the urban area, hand it over to the concerned body;
- 13) Prepare a standard for environmental protection based on the condition of the region; implement the same upon approval, control its implementation;
- 14) Control environmental impacts on any developmental activities;
- 15) Cause environmental impact assessment to be undertaken before project programmes are prepared by the government, non-governmental organizations and other organs; prepare impact assessment criteria, give same to concerned body, control its implementation;
- 16) Control industrial product remains and wastage released from urban areas not to pollute the ecological system, take corrective measure, cause to be taken;
- 17) Organize, store, administer data and information regarding rural land and environment; notify the concerned body;

- 18) Warshaalee fi industiriwwan irraa gataawwan summii qaban uumama naannoo irratti miidhaa akka hin geessisneef odiitii naannoo ni gaggeessa, bakka rakkoon jirutti tarkaanfii sirreeffamaa ni fudhata, akka fudhatamus ni taasisa;

- 20) Lafa baadiyyaa fi eegumsa naannoo ilaalchisee qaamota adda addaa waliin walitti dhufeenya ni taasisa;
- 21) Iddoon jireenya lubbu qabeeyyii adda addaa miidhamee jireenya isaanii irratti balaa akka hin qaqqabsiisne ni to'ata, badii uumamu irratti tarkaanfii ni fudhata, akka fudhatamu ni taasisa;
- 22) Manca'ina qabeenya uumamaa ni to'ata, badiin uumamee yoo argame qaama dhimmi ilaalu waliin tarkaanfii seeraa ni fudhata, akka fudhatamu ni taasisa;
- 23) Bulchiinsa lafa baadiyyaa fi eegumsa naannoo ilaalchisee qorannaa fi qo'annoo ni gaggeessa, bu'aan isaa akka hojii irra oolu ni taasisa.

4. Aangoo fi Ga'een Hojii Biiroo Industirii fi Misooma Magaalaa ilaalchisee keewwata 16 jalatti tumamee ture haqamee kan kanatti aanee jiruun bakka bu'eera:

- 3) Gosoota Industirii tarsiima'aa ta'aniif xiyyeeffannoo kennuudhaan deeggarsa addaa ni kenna;
- 4) Waldaalee ogummaa gama industiriitiin gurmaa'an ni jajjabeessa, deeggarsa barbaachisaa ta'e ni kenna;
- 5) Imaammata, tarsiimoo fi sagantaalee misoomaa fi bulchiinsa lafa magaalaa ni qopheessa, yoo hayyamame akka hojii irra oolu ni taasisa;
- 6) Sirni hammayyaa'aan misoomaa fi bulchiinsa lafa magaalaa akka diriiru ni taasisa, ni deeggara, ni to'ata, ni hordofa;

5. Power and Duties of Macro and Small Enterprise Agency next to Article 40(19) shall be added new Sub Articles 40(20) and 40(21) as follows;

- 20) Macro and Small Enterprise Agency shall organize macro and small enterprise associations; give license; renew; control; cancel; give support;
- 21) Audit Macro and Small Enterprise account, cause to be audited; inspect their performance and handling of property and take corrective measures.

6. Power and Duties of Transport Agency Next to Article 41(16) shall be added new Sub Articles, 41(17), 41(18) and 41(19) as follows:

- 17) Organize owners of public and goods transport vehicles in associations; give license, renew, control and cancel;
- 18) Take traffic controlling activities of transport vehicles; follow up and examine its performance; give corrections;
- 19) Register and keep car rental agreements.

3. City's Administration

Notwithstanding, the Power and Duties of City Administration Proclamation and other laws, it shall have the following power:

- 1) Develop and administer urban land found in city's master plan or demarcated to the city's boundary;
- 2) Register and issue legal personality certificates for persons organized in associations to construct residential houses based on directives issued; undertake study on conditions how residential houses can be built; implement upon approval;
- 3) Register contractual agreement pertaining to sale of house, rent of house and house under suretyship.

4. Effective Date
This proclamation shall come into force as of February 24, 2012.
