Whereas, Memorandum of Understanding

**1. Short Title**

This Proclamation may be cited as the "Memorandum of Understanding between the Ministry of National Defense of the Federal Democratic Republic of Ethiopia and the Ministry of Defense of the Republic of Burundi on Defense Cooperation Ratification Proclamation No. 877/2014"

## **2. Ratification of the Memorandum of Understanding**

The Memorandum of Understanding signed in Addis Ababa on the 7<sup>th</sup> day of October, 2011 between Ministry of National Defense of the Federal Democratic Republic of Ethiopia and the Republic of Burundi on Defense Cooperation, is hereby ratified.

### **3. Power of the Ministry of National Defense**

The Ministry of National Defense is hereby empowered to implement the Memorandum of Understanding.

#### **4. Effective Date**

This Proclamation shall enter into force on the date of publication in the Federal Negarit Gazette.
