**A PROCLAMATION TO RATIFY THE FINANCING
AGREEMENT BETWEEN THE GOVERNMENT OF THE
FEDERAL DEMOCRATIC REPUBLIC OF ETHIOPIA
AND INTERNATIONAL DEVELOPMENT
ASSOCIATION**

WHEREAS, A financing Agreement, between the Government of the Federal Democratic Republic of Ethiopia and the International Development Association stipulating that the International Development Association provide to the Government of the Federal Democratic Republic of Ethiopia a Loan in an amount not exceeding SDR 391,900,000 (three hundred ninety one million nine hundred thousand Special Drawing Rights) for financing Productive Safety Net APL IV Project, was signed in Addis Ababa on the 31st day of October 2014;

WHEREAS, the House of Peoples' Representatives of the Federal Democratic Republic of Ethiopia has ratified said Financing Agreement at its session held on the 29th day of January 2015;

NOW, THEREFORE, in accordance with Article 55 (1) and (12) of the Constitution, it is hereby proclaimed as follows:

1. Short Title

This Proclamation may be cited as the "International Development Association Financing Agreement for Productive Safety Net APL IV Project, Ratification Proclamation No. 884/2015".

2. Ratification of the Agreement

The Financing Agreement credit number 5540-ET signed in Addis Ababa on the 31st day of October 2014 between the Government of the Federal Democratic Republic of Ethiopia and International Development Association is hereby ratified.

3. Power of the Ministry of finance and Economic Development

The Ministry of Finance and Economic Development is hereby empowered to undertake all acts necessary for the utilization of the Loan amount of SDR 391,900,000 (three hundred ninety one million nine hundred thousand Special Drawing Rights) in accordance with the terms and conditions set forth in the Financing Agreement.

4. Effective Date

This Proclamation shall enter into force on the date of publication in the Federal Negarit Gazette.

Done at Addis Ababa, this 23rd day of February, 2015.
