| A PROCLAMATION TO RATIFY THE LOAN AGREEMENT BETWEEN THE GOVERNMENT OF THE FEDERAL DEMOCRATIC REPUBLIC OF ETHIOPIA AND THE GOVERNMENT OF THE ITALIAN REPUBLIC |
| <p>WHEREAS, the Agreement, between the Government of the Federal Democratic Republic of Ethiopia and the Government of the Italian Republic provides to the Federal Democratic Republic of Ethiopia a Loan in an amount of Euro 8,000,000 (Eight million Euro) for partially financing Promoting Basic Services program – Phase III Project was signed in Addis Ababa on the 5th day of September 2014;</p> <p>WHEREAS, the House of the Peoples' Representatives of the Federal Democratic Republic of Ethiopia has ratified the said Agreement at its session held on the 30th day of April 2015.</p> <p>NOW, THEREFORE, in accordance with Article 55(1) and (12) of the Constitution of the Federal Democratic Republic of Ethiopia, it is hereby proclaimed as follows:</p> |

1. Short Title

This proclamation may be cited as the "Government of the Italian Republic Loan Agreement for Partially Financing Promoting Basic Services Program-Phase III Project Ratification Proclamation No. 893/2015".

2. Ratification of the Agreement

The Agreement signed in Addis Ababa on the 5th day of September 2014 between the Government of the Federal Democratic Republic of Ethiopia and the Government of the Italian Republic is hereby ratified.

3. Power of the Ministry of Finance and Economic Development

The Ministry of Finance and Economic Development is hereby empowered to undertake all acts necessary for the utilization of the Loan amount of 8,000,000 Euro (Eight Million Euro) in accordance with the terms and conditions set forth in the Loan Agreement.

4. Effective Date

This Proclamation shall enter into force on the date of publication in the Federal Negara Gazette.
