<u>A PROCLAMATION TO RATIFY THE LOAN AGREEMENT BETWEEN THE GOVERNMENT OF THE FEDERAL DEMOCRATIC REPUBLIC OF ETHIOPIA AND THE AFRICIAN DEVELOPMENT FUND</u>
<p>WHEREAS, a Loan Agreement, between the Government of the Federal Democratic Republic of Ethiopia and the African Development Fund stipulating that the African Development Fund provide to the Government of the Federal Democratic Republic of Ethiopia a Loan amount of 28,482,000 U.A (Twenty Eight million Four Hundred and Eight Two Thousand Units or Account) for financing Drought Resilience and Sustainable Livelihoods Programme in the Horn of Africa: DRSLP II Ethiopia Project was signed in Addis Ababa on the 23rd day of February 2015;</p> <p>WHEREAS, the House of peoples' Representatives of the Federal Democratic Republic of Ethiopia has ratified said Loan Agreement at its session held on the 30th day of April 2015;</p> <p>NOW THEREFORE, in accordance with Article 55 (1) and (12) of the Constitution, it is hereby proclaimed as follows.</p>

1. Short Title

This proclamation may be cited as the “African Development Fund Loan Agreement for financing Drought Resilience and Sustainable Livelihoods Programme in the Horn of Africa DRSLP II Ethiopia Project Ratification Proclamation No. 894/2015”.

2. Ratification of the Agreement

The Loan Agreement Number 2100150032394 signed in Addis Ababa on the 23rd day of February 2015 between the Government of the Federal Democratic Republic of Ethiopia and the African Development Fund is hereby ratified.

3. Power of Ministry of Finance and Economic Development

The Ministry of Finance and Economic Development is hereby empowered to undertake all acts necessary for the utilization of the Loan amount of 28,482,000 U.A (Twenty Eight Million Four Hundred and Eighty Two Thousand Units of Account) in accordance with the terms and conditions set forth in the Loan Agreement.

4. Effective Date

This proclamation shall enter into force on the day or Publication in the Federal Negarit Gazette .
